Unit 112 Year End Education Report

Our Unit usually supports Education in several ways:

- In May each year, we present Scholastic Achievement Awards to one 5th grade young lady at each of eight different elementary schools. Unfortunately, with schools closed in May 2020, these awards were not presented in person. However, recipients for 2020 were selected and we delivered medals to the schools so they could be sent home with the students. We have already begun contacting seven elementary schools to get the names of one girl and one boy for the 2021 Scholastic Achievement Awards and we are looking forward to presenting medals in person at the end of the year ceremonies in May 2021.
- Each year, we usually recognize the teachers and staff at three schools with huge goody baskets of fruits and breakfast pastries during National Teacher Appreciation Week. However, this program was put on hold since schools were not in session for in-person learning in May 2020. If we can gain access to the schools next month, we will again deliver the goody baskets to the schools.
- In the past, we collected school supplies for three elementary schools, but two years ago, we were asked to switch gears a bit because they each got more school supplies than needed and indicated that they could use other items. We have adopted the food pantry at one elementary school and just before Thanksgiving, we provided the non-perishable Thanksgiving dinner items (candied yams, marshmallows, stuffing, gravy, canned corn, canned green beans, cranberry sauce, and mashed potatoes) for the families identified as on free breakfast and lunch. Many of these families are active duty or veteran families. This year, because so many student families have chosen Seminole

Connect virtual school, we provided about \$500 in food items for the school's families.





- For Give Ten to Education this year, we adopted one classroom and participated in the Scholastic Books Classroom Book project. For \$10 per student, Scholastic Books will provide one book per month for each student in the classroom. We donated \$250 to provide each of 25 students with a book every month this school year.
- One of our members is also very active teaching various classes in the community and spent more than 130 hours preparing for her classes and teaching those classes.

Even through the pandemic and with our Post home closed all year, our little Unit has been able to continue to support Veterans in our community. We have several major projects that we do each year that fall under VA & R:

- For Christmas each year, our members shop for traditional Christmas dinner non-perishable food items that are placed in three huge baskets to be given to Veteran families in need. The baskets have at least \$100 in food items each plus each one has a \$25 Publix gift card that allows the family to shop for meats and other perishable items they need for their holiday dinner. This year, our three food baskets were delivered to the Lake Baldwin VA and given to Giving Tree families. Total amount spent for Christmas 2020 was \$375.00.
- Our members assist the Post members when they shop for their VA Giving Tree family each Christmas.
- One of our members is a caregiver to one of the Post members. She visits him
 regularly just to keep him company since he has no family in the area. While she
 visits, she does his laundry, cooks his meals, and cleans his apartment. She also
 goes his grocery shopping and transports him to doctor's appointments.
- One of our members is the newsletter editor for the Legion Family newsletter that is published 6 times per year. She also provides photography services for the Post for their scrapbook since the Post no longer has a Historian.
- One member provides bookkeeping services for the Post and the SAL Squadron, making daily Post Office runs, paying bills, maintaining QuickBooks, and making regular bank deposits.
- One member maintains the Post's Facebook page and group and provides technical support so the Post can stream various programs like Veterans Day, Memorial Day, and the Four Chaplains service to Facebook live.
