Unit 112 2023-2024 Year-End Public Relations Report

Unit 112 is continually active publicizing not just our Unit but also the American Legion Auxiliary organization, the Legion, and the Sons of the Legion.

While we have not sought out media coverage for any activities, we are active on social media, having a website, and both a Facebook fan page and a Facebook Group. We always have a full-page article with pictures in our Legion family bi-monthly newsletter.

This year, we had several opportunities to be visible in the public:

- Every year since 2017, one of our members does a presentation for one of the local Rotary Clubs where she explained all the Auxiliary programs and how Unit 112 specifically supports every program. Also included in the presentation was information about the full Legion family and she was able to assist with recruiting new members for the Legion family. This year, we were fortunate to receive a grant funded by the Rotary Foundation to help support our programs like Education, Girls State, and Americanism.
- For Veterans Day, our unit members were invited to attend the Veterans Day program at Eastbrook Elementary School where we were able to have a membership table. We greeted all the Veterans and their families as they entered the room and we gave out full family information packets, including applications, and we made sure that every Veteran attending was given a Poppy (no donations were accepted) and a small table-top sized American flag. We were joined by members of Post and squadron 112 who helped to explain the Legion and Sons programs.
- One of our members is the editor for our Legion Family newsletter. In addition to the time she spends writing our Auxiliary article for each newsletter, she spends about 10-12 hours assembling the bi-monthly Post 112 family newsletter.

Legion Department Convention Updates

The Department Convention was quite interesting. One of the things that was mentioned was that the National American Legion may have to discuss dues increase in 2025. It will be discussed at their National Convention in Charlotte, NC, in August, so we may be hearing more about it after their convention and at our 6th District meeting in September.

Another item discussed was the ability of the members to pay 3 years of dues at one time. This may become effective in January, but we will keep you posted. If this happens, you will be able to pay the current dues rate for 2024, 2025 and 2026 regardless of any dues increase. That could save you some money in the short term. Of course, the dues are non-refundable. You will only be able to renew one year at a time by mail.

Did you know that you have a National American Legion account online? If you have not registered your account, go to <https://mylegion.org> and "click on" "register" in the upper right corner. You will be asked for your email address, and it must be the one that you have given the Adjutant to send to National. If you don't remember what it is, send Bob a note to FLPost112@gmail.com and he will send what is in our records have back to you. If you did register an email with National, send Bob a note with which email address you want to use, and he will notify National and let you know when it is ready. And, if you want to change your email address at National, let Bob know. Once you have your account registered, you can change it yourself, just remember to notify the Adjutant so the Post records stay up to date.



Notes From the Adjutant's Desk

We are starting the new fiscal year with the installation of officers at the Post on July 11th at 7 PM. Since we have the Auxiliary and Son's, we will have the entire Post Family installed at the same time. The new District staff will be on hand to receive the acceptances. There will be some "munchies" after the installation.

In August, we plan to have our Boy's State and Girl's State delegates attend the general meeting and give us a report on what they thought of Boy's State and Girl's State. We also plan to have some "munchies" after the meeting, too.

Our meetings will continue to be streamed on ZOOM for those who are not able to get to the Post. If you have a "smart" phone, you can actually see the meeting online through your phone. If you don't have a "smart" phone, you can DIAL in and listen to the meeting. If you need personal instructions on how to attend the meeting, let me know. **Remember, your vote counts!**

The year is just beginning! Don't you want to be a part of it?

Just to review a few things from the past year, we have taken on the sponsorship (chartered partners) for two Boy Scouts of America Scout Troops. The troops are Troop 613 (a boy troop) and Troop 4613 (a girl troop). Since we have become associated with them, two girls have earned their EAGLE rank and one boy has almost finished his EAGLE. You may see them at the Post from time to time. To remind you, the Four Chaplain's Memorial in front of the pavilion and the flag collection box outside our front door were EAGLE projects of two of the boys from Troop 613.

We have had some changes at the Post, too. With the addition of the Scout Troops comes the usual "camping trailers" that most troops have. We have added parking spaces for them in the back. We placed "pavers" so that the trailers would not be sitting in the dirt and the grass growing up around them. The pavers will keep the grass away and give the trailers a solid place to be stored. We also added some dehumidifiers to end the "musty" odor that had permeated the Post for years. You can tell im-

mediately when you come into the Post.

Over the next couple of months, we will be improving the building and premise security. We need to be able to have a better view of the premise and we will be adding "inside" cameras so that we can check on the entire Post. The improvements to the security system are actually overdue.

I would like the amateur radio operators (hams) to identify themselves. National American Legion has an Amateur Radio Club. There are no dues, but you do need to be a member of the Legion Family (Legion, Sons or Auxiliary). We can form a local "club" if we have enough interest. From there, who knows what can develop.

Our Happenin' Auxiliary—Nell Colbert

Our Unit was saddened to learn that long-time member Staci Shannon-Klinger passed away on May 27th. Staci had been an Auxiliary member since she was about 4 years old and transferred into Unit 112 in 2011. Staci's eligibility for the Auxiliary came through her father, Post 112 member, Dyke Shannon. Staci was only 48 years old and leaves behind a 10 year-old son. Please keep Debi, Dyke and the entire Shannon and Klinger families in your prayers as they deal with this tragic loss.

Our Unit was well represented at the recent Department of Florida annual convention held 6/14-6/17. Marge, Nell, and Laurel attended several classes as well as the general sessions to vote for the 2023-2024 Department Officers and vote on proposed amendments to the Department's Constitution and By-Laws/Standing Rules. The major change at the Department level was that of making the Department Secretary an unpaid, volunteer position appointed by the newly elected Department President. There are now three full-time paid staff at Department—the Office Manager, Treasurer, and Membership Processing.

Another change announced was the discontinuation of membership credits to process memberships from the Units. When members pay their dues on-line using the National Auxiliary portal, a membership credit is generated for the Unit. As a benefit to the Units, membership credits will be paid to Units monthly via

ACH deposit rather than being paid annually on July 1st for the preceding year.

Our Membership Drive for 2023-2024 kicks off July 1st. Because of the dues increase approved at the Auxiliary National Convention and the Department of Florida Convention in 2022, our Unit approved a dues increase in November 2022 to accommodate these increases. Our Unit portion of the dues did not increase—just that portion of what we collect that we pass on to Department and National. Our 2024 dues will be \$45 for each Senior member and \$12 for each Junior member. You will receive our annual dues renewal letter from our Unit Secretary-Treasurer that will arrive in your mailbox around July 1st. Please do not wait for the renewal invoice from National as they are not mailed until October; if you pay for 2024 now, we can save National some postage (remember stamps go up July 1st and we could help to avoid another National dues increase for next year.) We need to be at 100% before the end of November so we can apply for an over-quota Girls State delegate for 2024. Thanks for paying your 2024 dues before the deadline.

Since our last newsletter, we've been busy presenting Americanism Essay contest certificates and medals to two elementary school winners and four high school winners. We also presented Scholastic Achievement certificates and medals at eight elementary school graduating 5th

We also assisted the Post with the Memorial Day program. Auxiliary members provided side dishes to go along with the awesome meal from Dustin's BBQ. Again, lots of pictures from the event can be found on our Facebook page and on Page 10.

By the time you read this, our Girls State delegates will be home from Tallahassee. We were thrilled to learn that both of our alternates were picked up by other Units around the state who could not select girls from their areas to represent them. Our delegates will be giving their updates in person at Post 112 on August 8th beginning at 7pm.

Our installation of officers will be held in-person at Post 112 on July 11th, beginning at 7pm.

Please join us on 7/11 and 8/8. Zoom will also be available for those unable to travel to the Post—watch your email.

Notes from Our Service Officer

Navy Revamping Living Conditions on Aircraft Carriers

Based on a quality-of-service investigation, the Navy is revamping manning requirements, living conditions and mental health access for sailors assigned to aircraft carriers undergoing maintenance in the shipyards. These improvements come after a separate investigation into the rash of suicides among sailors assigned to the carrier George Washington revealed how the challenging work environment at a Newport News, Virginia, shipyard had negatively affected their quality of life.

D-Day 79 Years Ago

This month (Tuesday, June 6) marks the 79th anniversary of the World War II invasion of Normandy, France, by Allied troops. Commonly referred to as D-Day, it was the largest naval invasion in history and eventually led to the end of the war in Europe. Salutes go to all WWII veterans on this special anniversary, particularly those who fought on June 6, 1944.

New technologies to enhance Veteran access

In July 2022, Veterans had a new way to reach the Veterans Crisis Line by dialing 988 and pressing 1. This new number addressed the need for ease-of-access and clarity in times of crisis for both Veterans and their families. In FY 2022 over 717,000 calls were answered by the hotline. The Veterans Crisis Line can also be reached by text ([838255](tel:838255)) or [chat](#).

Deploying updated phone system technology and software tools to increase the efficiency of contact centers remains a core priority for contact center modernization efforts. But telephone isn't the only way to reach VA.

Two new methods were introduced last year: [AskVA](#) and VA [Chatbot](#). Both were designed to provide Veterans with quick and easy access to VA customer service and information-

al resources. AskVA consolidates previous online inquiry services into one system that makes it easier for Veterans to submit questions, concerns and recommendations. The submissions are routed to the appropriate VA service and users can receive secure messages and track their issue from submission to resolution. Last year, 356,000 inquiries were received through AskVA, with 98% successfully resolved.

About the Caregiver Support Program

The Caregiver Support Program (CSP) promotes the health and well-being of Veterans' caregivers through education, resources, support and services. Every VA facility has a CSP team that provides valuable information about resources to help caregivers stay informed and supported as they support Veterans. Contact your [CSP team](#) to learn about the resources available. Caregivers of Veterans can learn about CPR training opportunities offered through VA by contacting their local [CSP team](#).

Veterans can electronically access their VA decision letters online. The Decision Letter Download Tool allows Veterans to download their decision letters using [VA.gov](https://va.gov).

Any Veteran with a [VA.gov](https://va.gov) login can use this tool, which provides instant access to decision letters. Veterans no longer have to speak with VA or wait for a paper letter in the mail to know the decisions made on their claim.

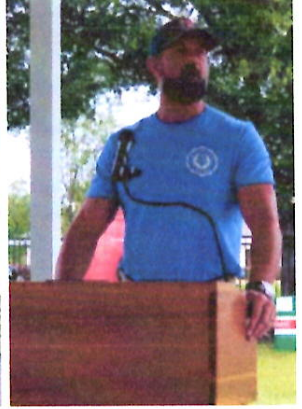
