




We were very happy to support and participate in the Legion Family Memorial Day program where we were not only a part of the program, but we also had the oppor-

Notes from Our Service Officer

The House Veterans' Affairs Subcommittee on Economic Opportunity met for the proposed bills included H.R. 7543, *Guard and Reserve GI Bill Parity Act of 2024*, It recognizes the sacrifices that National Guard and Reserve members make when serving stateside, during short activations, and on long deployments. It would allow any day in uniform receiving military pay to count toward Post-9/11 GI Bill eligibility.

National Veterans Service Director Michael Figlioli testified at a House Subcommittee on Disability Assistance and Memorial Affairs oversight hearing on the question of whether a rating of Total Disability based on Individual Unemployability (TDIU) properly compensates today's veterans. Eligible individuals receive a 100% disability rating if their service-connected disabilities preclude employment. Figlioli commented, "Discussions around TDIU often focus on financial aspects, but at its core it's about people whose lives have been irrevocably changed."

Refill Your Rx on VA Mobile App

You can now request refills and track your prescriptions using the <u>VA Health and Benefits</u> <u>app.</u> Existing users will need to download the latest version of the app to gain access to these new features. The app is free and available for both iOS and Android smartphones.

Aid & Attendance for Qualified Veterans

Did you know you can receive tax-free payments added to your monthly VA compensation through our <u>aid and attendance or household benefits?</u> It's available to Veterans, single surviving spouses and dependent children. For more information, find your <u>nearest VA Regional Office for assistance</u>.




At the time that I wrote this article, our Delegates were in Tallahassee. By now, they should all be excited with what they have seen and done and looking forward to the next two days and coming home.

Dues Increase and Paying Online

Welcome to the 2024-2025 membership year! Things are looking better, and we are hoping to have an active year, with your help.

As you will see, the dues have gone up to \$45/year. This was unavoidable with the costs for National and the Department of Florida raising the amount of your dues that go to them.

There is one thing that you can do to give yourself a small break, and that is to pay your dues ONLINE. When you pay them online, you can pre-pay for two more years at the current rate. So, if you were to pay for 2025, 2026 and 2027, and the dues were increased again in 2027, you would not be affected until 2028. **This can only be done online.**

There is also a new feature that allows you to "auto pay" by credit or debit card. Your credit or debit card would be charged on or after July 1st each year and you wouldn't have to worry about paying your dues. The "auto pay" will only pay the current year. You would have to update your card information when it expires, though.

The next question is "Do you have an ONLINE account?" If not, you can set one up by going to https://mylegion.org and REGISTERING. You can do this regardless of whether you are paying your dues or just want to update your information at National. Information like emergency contacts, phone number, address change, print a replacement membership card and more can be done-by-you will need an email address and it must be the same one that you provided the Post. If you have changed email addresses, please advise the Adjutant so that the National records can be updated. Once this is done, you can register for your Legion account. You will be asked for your membership number (printed on your membership card) and your email address to confirm your identity.

If you have any questions or problems with registering or about the ONLINE process, contact the Adjutant.

In case you hadn't noticed, the school year is over and summer vacation is upon us. That means that the School Medal season is done.




Our Post distributed medals to seven Elementary Schools, two School High NJROTC units and the


